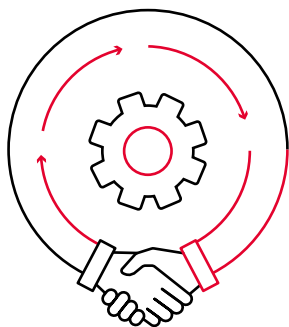

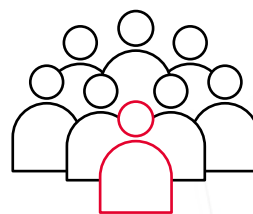

The **Trophée d'Or 2026** was awarded to Séquoia in March 2026 for a one-year period by the editorial staff of *Le Revenu*.

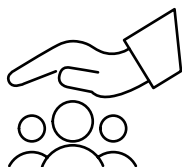

The **Oscar for Best Customer Service** was awarded in April 2026 for a one-year period by the editorial board of *Gestion de Fortune*.

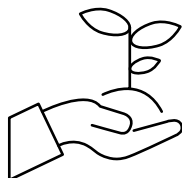
The **2026 Le Figaro Best Personal Protection Insurance** award was presented in December 2025 for a one-year period by the IAQ Institute.

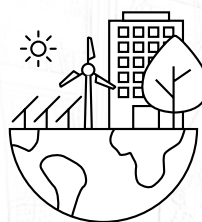

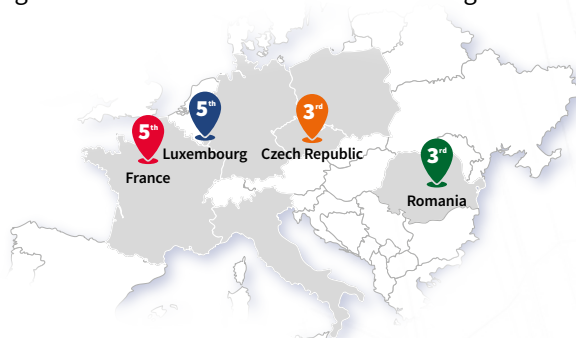
